The intent of this Tournament is for fun, friendship, and an opportunity to participate competitively in Table Tennis. Players of all skill and age levels are welcome.

Regulation: This event will follow "The Laws of Table Tennis Chapter 2 www.ittf.com unless modified herein or by the Tournament Directors.

Equipment: Stiga and/or Butterfly tables will be used. White 40+mm three star Balls will be used.

Release Forms: All participants must sign the Release Form. ALL Minors under 18 yrs MUST have parent/legal guardian sign release form.

Participant check in: 15 minutes prior to the start of your event. Event time is forfeit time. All participants must have non-marking clean gym shoes!!!

Special Tournament Regulations: Players may wear shorts, slacks, or athletic pants. Same color shirts are encouraged but not mandatory for the Team Event.

Ratings: Each player will be given a Tournament Rating by the Directors. This rating will be based on the Home Club's recommendation and previous tournament play. After the Singles Matches, if a player's rating is out of line with the other players, a representative from Yukon and Alaska will meet with the Head Referee and work out a reasonable solution.

Handicap: This is a Point System Event. For every 50 points difference in rating 1 point will be subtracted from the higher rated player prior to the match. All games will be scored to 11 points with a win by 2 points. If time allows, matches will be best 3 of 5 games, except in matches where 12 or more points are given, which will be 2 out of 3 games. *The number of games per match will be determined after all the entries are received.*

Singles Event: There are two divisions: Open for those with a Tournament Rating of 1,000+ and Novice for those with a rating of 999 and under. The minimum rating will be 500.

Team Event: Each Team can have two or more players. All players will play in the highest member's division. Individuals with a 1000 plus rates must play in the Open and Open Teams. The minimum rating in the Open is 1000. Each Tie will consist of a doubles match and 2 singles matches. The single matches will have top play players playing each other and the 2nd rated players playing each other.

Individuals, who want to play in the team event and do not have a partner, need to contact a Tournament Director.

TIPS: Good Sportsmanship is expected. Bring a sports bag, towel, athletic clothes (No White Shirts), water bottle & energy food.

FOOD: Snacks, water, and sandwich items will be provided by FITT on Saturday. Food must stay in designated area.

Deadline: FEES & COMPLETED FORM MUST BE RECEIVED BY June 2 by 9 PM to avoid late fee. Late entries accepted only if approved by the Director, and will cost \$25.
